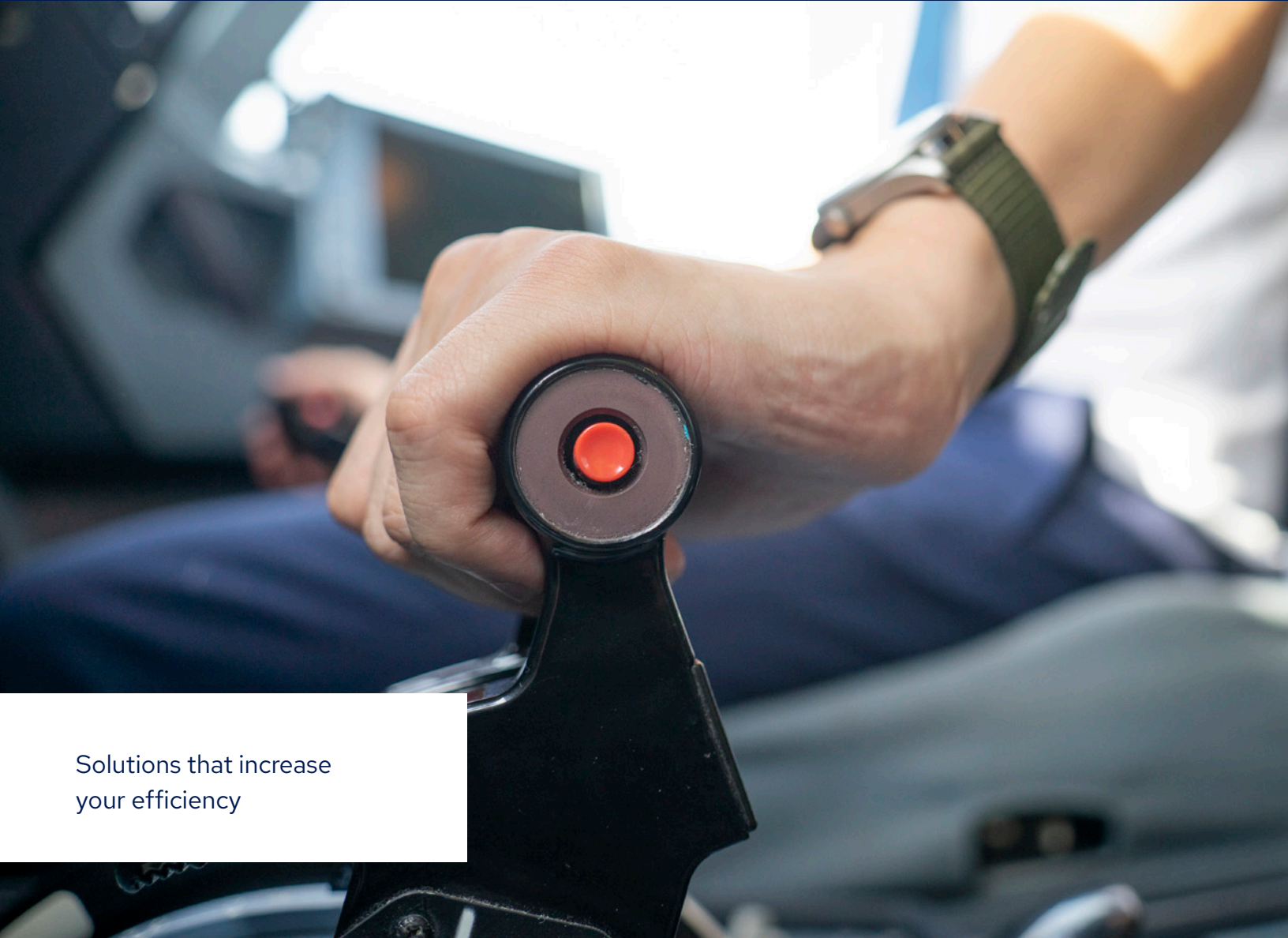

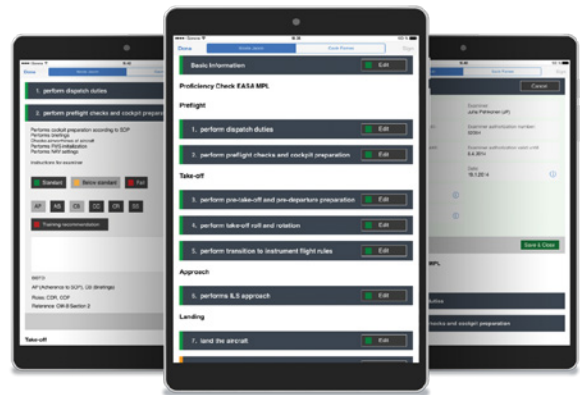

Scheduling System

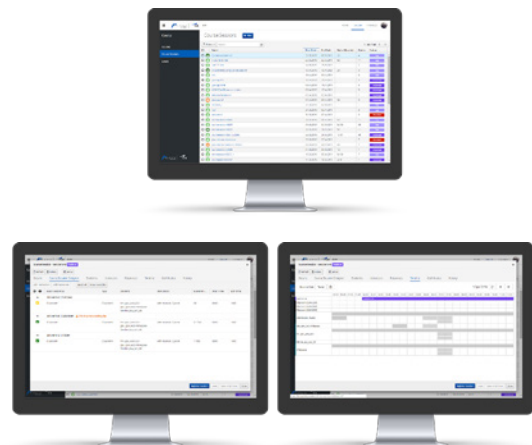

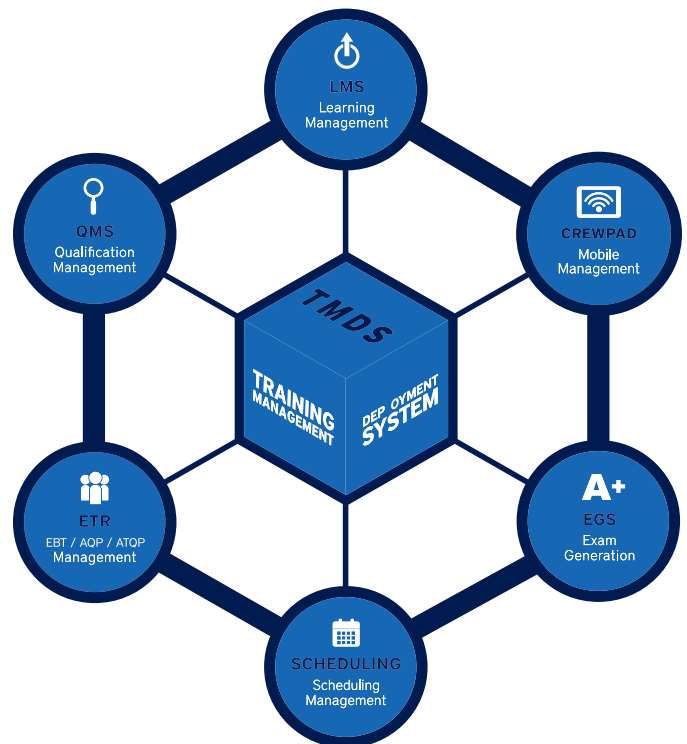
