CAE signs five-year contract renewal with Flight Options for pilot training on multiple business aircraft types

Atlanta, Georgia, October 18, 2010 – (NYSE: CAE; TSX: CAE) CAE announced today at the National Business Aviation Association (NBAA) annual convention the signing of a five-year contract renewal with Flight Options for pilot training services covering six fleet aircraft types – including the Beechjet 400A, Cessna Citation X, Hawker Beechcraft 800XP and 800 XPi, and Embraer Legacy and Phenom 300.
