- All 4,200 members of the Society for Simulation in Healthcare (SSH) will have free access to iRIS and the SCE for download and customization during the COVID-19 pandemic

Montreal, Canada, March 24, 2020 – CAE Healthcare and UK-based iRIS Health Solutions announced today that CAE's COVID-19 Simulated Clinical Experience (SCE) for healthcare is now available and free of charge to the global iRIS community. iRIS and the SCE will shortly be made available free of charge to the full membership of the Society for Simulation in Healthcare (SSH), which has 4,200 members in 60 countries, to aid collaboration and sharing between members at this time.

iRIS is a healthcare training authoring and sharing platform with more than 1,800 users worldwide. It allows physicians, educators and healthcare professionals around the world to create, share, and download simulation training for use on simulators from different manufacturers.
